Spraying

- 104 quarters private land mainly leafy spurge
- 89 miles of road tree spraying
- 23 locations hand-picked for noxious weeds
- Sprayed MD yards and firehalls and water treatment plant site
- 1 transfer site Hayter
- 1 borrow area

Road Reclamation

- Last year's projects completed
- 8 miles on 402 rocks, discing, seeding and some fencing
- 6.5 miles on Kessler Hall road rocks, discing, seeding and some fencing
- 1 mile reseed grass
- ½ mile pick rocks and roots
- Total of 16 miles from 2015 and 2016
- Reclaimed 29 acres of Cullen gravel pit rocks, roots, discing, rock raking - rocks and grass seeding
- Started working Aug. 1 on this year's road 402 by the Hutterite Colony – discing and rock picking to this point

Pest Control

- 1 rat report identified and baited and think we have it under control and we are monitoring
- Gopher strychnine sales 1736 bottles to date in 2017
- 9 bottles of phostoxin
- 30 pellets of 1080 (sodium fluoroacetate)
- Approx. 7200 chemical jugs picked up and transferred from pesticide sites to the main holding site at Provost landfill
- I now have my 3 rabies shots to be safe from getting a bite
- Held a Pest Control Meeting in Provost at the Canalta, for all the MD's down Sask. Border to the states and reviewed policy rabies and skunks wild boar demonstration on killing a skunk with carbon dioxide and removing skunk head and bagging head for rabies testing we need to send 10 heads in per year now I have started on building the skunk terminator unit
